2	Invoices not paid by the 10th of the month are past due. Past due accounts are placed on COD status and interest charges of 1 1/2% of the invoice total per month. Past due accounts may also be subject to closure and may not be eligible to be reopened.
3	J&W Lumber may employout side collection agencies to collect past due accounts, and the undersigned agrees to pay all actual costs of collection, attorney's fees and interest on the past due amount at the highest rate legally available.
	Accounts that remain inactive for a 12-month period will be closed.
5 6 7 8	Any changes in owners, authorized buyers, addresses, telephone number, or any other information furnished on the application for credit shall be reported to J&W Lumber immediately.

The information herein is furnished for the purpose of obtaining credit and by signing below Buyer(s) warrant that this application is full, true and correct as of the date below and that Seller will be notified of all future changes. It is understood and agreed that the undersigned specifically consent to credit history investigation that may include inquiry to outside credit reporting services to obtain information. Each signer below is responsible for all charges to this account and agrees to comply with the following Terms of Sale. The Terms of Sale are applicable to all quotations and sales, unless agreed upon in writing by Seller. No terms or conditions of Buyers purchase order that are different from the terms herein will become part of any sales agreement, unless approved in writing by Seller.

All invoices are NET 10th prox; due and payable in full on the 10th of the following month. The prices charged are with the expectation of payment being made within these terms. Buyer agrees to pay seller 1-12% per month, 18% annum, on past due amounts as liquidated damage charges for each month thereafter as an adjustment of the price until paid and agrees that this is a fair and equitable approximation if the actual expense incurred by Seller. Seller reserves the right to take legal action to collect delinquent amounts. Should suit be filed to collect any debt, Buyer agrees to pay all actual administrative costs, attorney's fees, and interest on past due amounts at the highest rate legally allowable. A \$35.00 service charge shall be added to all returned checks. Seller may from time to time require additional or updated credit information and will be furnished by Buyer upon request. Failure to comply with any Terms of Sale may cause the account to be placed on COD basis or closed. Accounts that exceed the approved credit limit will be subject to COD status and the balance exceeding the credit limit established will be immediately due and payable.

Claims for shortages or variances must be made within 3 days. Credit for stock items may be allowed, subject to a 15% restocking charge, cartage to yard, and condition of material. Special Orders may not be returned. Deliveries are to curbs only with no responsibility to Seller for broken sidewalks curbs or other improvements when delivery is requested elsewhere. All purchases remain the property of Seller until paid in full.

Information pertaining to the filing of a California Preliminary Lien will be required on all orders or combination of orders exceeding \$300.00 and will be furnished By seller upon request. The contract resulting from acceptance of Buyer's order shall not be assigned by the Buyer without the prior written consent of the Seller. Pursuant to the applicable provisions of the California Civil Code each signer agrees to notify Seller in writing within reasonable time of any pertinent change in the above information herein including name, address, telephone, principals, or financial condition. Each signer agrees to notify Seller immediately in the event an unauthorized use of this account has occurred or may occur within a reasonable time after the discovery thereof and will assist Seller in determining the facts and circumstances relating to any unauthorized use of this account.

Seller's waiver of any breach or failure to enforce any of the terms and conditions at any time shall not in any way affect limit or waive Seller's right thereafter to enforce and compel strict compliance with every term and condition thereof. The undersigned further expressly consent to Seller to communicate to Credit Reporting agencies employers/employees and or any family member in connection in connection to any indebtedness incurred in this account. This document and all rights and obligations hereunder shall be governed in accordance with the laws of the State of California.
